STUDENT CODE OF CONDUCT

PURPOSE

The Lancaster County Public Safety Training Center recognizes that it is necessary to establish guidelines for conduct in order to ensure protection of rights for the individual and for the Public Safety Training Center and its instructors.

GENERAL

The rights of all members of the Public Safety Training Center, students, instructors, administration and guests shall remain inviolable:

To learn, teach, study without interference or harassment.

1. To move about the Training Center and buildings freely without interference or harassment of any kind.
2. To be treated at all times with the courtesy and respect due to all human beings, regardless of ethnic origin, cultural background, sex, creed or ideology, as long as one displays a decent regard for the rights of others.
3. To dress accordingly.
4. To be punctual, attentive and non-disruptive in class.
5. To follow instructions of the staff at all times while maintaining situational awareness.
6. To report all injuries to the Lead Instructor.
7. To make sure that all technological devices are turned **OFF** or in vibrate mode.
8. To wear appropriate Personal Protective Equipment (PPE) when required.

UNACCEPTABLE CONDUCT

The following list constitutes practices and conduct which are unacceptable for any member of the Training Center, students, instructors, administration and guests:

1. Hateful graffiti and other offensive expressions of prejudice and ignorance will not be tolerated.
2. Unauthorized use, possession, or sale of narcotics, illegal substances, firearms or other dangerous weapons.
3. Drunk or disorderly conduct.
4. Possession of alcoholic beverages.
5. Theft of Training Center property or personal property.
6. Destruction of, damage to, malicious misuse of or abuse of Training Center or personal property.
7. Unauthorized use of or borrowing of Training Center equipment.

2012 CERTIFICATION TESTING

The Lancaster County Public Safety Training Center is accredited by the Pennsylvania State Fire Academy and the Office of the State Fire Commissioner as field test site #26 for National Board on fire Service Professional Qualifications testing.

Certification candidates are required to complete a certification application for the respective exam they are interested in. The completed application, with all required prerequisites attached, **MUST** be returned no later than (3) weeks prior to the test date. There will be **NO** exceptions to this rule. Any applications that are received and judged to be incomplete will be returned to the candidate. At no time will a candidate be allowed to test without all prerequisites being met and submitted with their application.

FIREFIGHTER I

May 11 (Written Exam) at 7:00 PM and **May 12** (Practical Exam) at 8:00 AM

September 14 (Written Exam) at 7:00 PM and **September 15** (Practical Exam) at 8:00 AM

Prerequisites - 18 years of age; Basic First Aid or higher; CPR (Adult/Child/Infant); Hazardous Materials Operations; Del-Mar Mod IV with Live Fire; EBM, only under conditions met on the application; PA State Fire Academy Structural Burn Session (SBS)

COST - \$175 per candidate - includes written and practical testing

FIREFIGHTER II

June 8 (Written Exam) at 7:00 PM and **June 9** (Practical Exam) at 8:00 AM

October 19 (Written Exam) at 7:00 PM and **June 20** (Practical Exam) at 8:00 AM

Prerequisites - Firefighter I Certification; Vehicle Rescue Operations or higher; Hazardous Materials Operations; NFA NIMS 100 & 200 or NFA NIMS ICS for EMS or the Fire Service

COST - \$175 per candidate - includes written and practical testing

DRIVER / OPERATOR - PUMPER

June 17 (Written and Practical Exam) at 8:00 AM

Prerequisites - 21 years of age; Valid Drivers License; Firefighter I Certification

COST - \$150 per candidate - includes written and practical testing

HAZARDOUS MATERIALS AWARENESS

January 18 (Written Exam, There is no Practical Exam) at 7:00 PM

Prerequisites - 14 years of age; Hazardous Materials Awareness

COST - \$25 per candidate

HAZARDOUS MATERIALS OPERATIONS

March 25 (Written and Practical Exam) at 8:00 AM

Prerequisites - 16 years of age; Hazardous Materials Awareness Certification

COST - \$150 Per candidate

2012 CERTIFICATION TESTING - Continued

FIRE OFFICER I

September 24, 26, 29, October 1, 3, 8, 10, 13, 15, 17 - Weekday sessions begin at 6:30 PM; Weekend sessions begin at 8:00 AM

This course will provide the student with a basic knowledge of management principles in a fire/rescue organization. Topics of discussion will include management style, communication modes, leadership, organization structure, pre-planning, health and safety and legal aspects for a fire officer. Successful completion of the program requires proficiency demonstration in written practical skills and a multiple choice examination.

Prerequisites - Firefighter II; NFA-ICS; Fire Service Instructor I; Hazardous Materials Operations or higher

COST - \$325 per candidate - includes course, books and certification testing.

FIRE OFFICER II

February 11, 12, 25, 26, March 10, 11 - Weekend sessions begin at 8:00 AM

This course continues to reinforce the job requirements of the Fire Officer I program, while examining critical issues in leadership, human resources, instructing, community interaction and finances. Topics will include basic investigation techniques, operation plans and communicating in written medium. Successful completion of the program requires proficiency demonstration in written practical skills and a multiple choice examination.

Prerequisites - Fire Officer I; Hazardous Materials Operations or higher

COST - \$325 per candidate - includes course, books and certification testing.

FIRE OFFICER III

November 3, 4, 7, 14, 17, 18 - Weekend sessions begin at 8:00 AM

This course continues to reinforce the job performance requirements of Fire Officer II; however, begins the progression to an administrative level officer. Critical elements that will be presented include hiring, promotions, injury prevention, recordkeeping, budget administration and planning. All skill elements are of the written medium and expected to be produced at a college level. There is no written examination.

Prerequisites - Fire Officer II; Fire Instructor II; Hazardous Materials Operations or higher

COST - \$325 per candidate - includes course, books and certification testing

FIRE INSPECTOR I

March 19, 20, 21, 22, 23 - Weekday, day-time offering, all sessions begin at 8:00 AM

This is an entry level course for firefighters or new inspectors wanting to be a fire prevention inspector. Topics covered in this course include: building construction, decorative materials and furnishings, fire drills, inspection procedures, code enforcement, fire alarm systems and communications. Successful completion of this program requires practical skill demonstration and a written, multiple choice examination. The Fire Inspector I course requires students to have a high degree of motivation, as significant course work is required outside of the classroom. Successful completion of all requirements will result in certification through the International Fire Service Accreditation Congress (IFSAC). This course and its testing component are being administered by the Bucks County Community College.

Prerequisites - Hazardous Materials Awareness certification (will be administered as part of the course)

COST - \$375 per candidate - includes course, books and both certifications

2012 CERTIFICATION TESTING - Continued

FIRE INSTRUCTOR I w/ EDUCATIONAL METHODOLOGY

August 25, 26, September 8, 9, 25, 26 - Weekend sessions begin at 8:00 AM

This course will provide instruction in adult learning, teaching techniques, preparations of course objectives and formation of lesson plans that meet those objectives. Various formats of audio-visuals will be demonstrated. Each student will prepare and deliver several microteaching sessions on fire related topics as part of the course work. Successful completion of this course is required to become an instructor without prior teaching experience.

COST - \$350 per candidate - includes course, books and certification

CLOSED CERTIFICATION TESTING

Closed certification testing is available to fire departments that wish to do so. For a closed session, a fire department should have at least (12) candidates for testing. Notification to LCPSTC should be at least (120) days in advance to properly schedule and complete the testing application and required paperwork. 2012 SUPPRESSION TRAINING DELMAR CURRICULUM

All students will be supplied with the DELMAR set "Essentials of Firefighting and Emergency Response, Pennsylvania State Fire Academy Custom Edition". This set MUST be retained by the student and is REQUIRED for all four modules. The cost of the set is built into Module I only. If the set is lost, damaged or otherwise unusable for future modules, the student will be responsible to purchase a new set.

INTRODUCTION TO THE FIRE SERVICE (Module I) - (16 hours)

January 3, 5, 7 Weekday sessions begin at 6:30 PM, Weekend session begins at 8:00 AM

August 18, 19 Weekend sessions begin at 8:00 AM

This program is designed to equip the entry-level firefighter with the basic knowledge, skills and abilities to begin their fire service career. It introduces new firefighters to basic information including an overview of the fire service, the fire service organization, firefighter safety, personal protective equipment and terrorism awareness.

Prerequisites - 14 years of age

COST - In-County \$145; Out-of-County \$170

FIREGROUND SUPPORT (MODULE II) - (48 hours)

January 17, 19, 21, 24, 26, 31, February 2, 7, 9, 11 Weekday sessions begin at 6:30 PM, Weekend sessions begin at 8:00 AM

August 25, 26, September 8, 9, 25, 26 Weekend sessions begin at 8:00 AM

This program is designed to equip entry-level firefighters with basic knowledge, skills and abilities as they relate to fire ground and hazardous materials emergency scene operations. It introduces new firefighters to basic information including fire behavior, portable fire extinguishers, water supply, fire hose and appliances, ropes and knots and hazardous materials.

Prerequisites - 14 years of age; Introduction to the Fire Service (Module I)

COST - In-County \$145; Out-of-County \$165

EXTERIOR FIREFIGHTER (MODULE III) - (42 hours)

February 21, 23, 25, 28, March 1, 6, 8, 10, 13, 15 Weekday sessions begin at 6:30 PM, Weekend sessions begin at 8:00 AM

October 6, 7, 13, 14, 27, 28 Weekend sessions begin at 8:00 AM

This program is designed to equip the entry level firefighter with the basic knowledge, skills and abilities as they relate to exterior fire ground operations. It introduces new firefighters to basic information including building construction, ladders communications protective systems and sprinklers, forcible entry and fire prevention.

Prerequisites - 14 years of age; Fireground Support (Module II)

COST - In-County \$160; Out-of-County \$180

INTERIOR FIREFIGHTER with LIVE FIRE EVOLUTION (Module IV) - (60 hours)

March 27, 29, 31, April 3, 5, 10, 12, 14, 17, 19, 24, 28 Weekday sessions begin at 6:30 PM, Weekend sessions begin at 8:00 AM

October 31, November 3, 4, 7, 10, 11, 14, 17 Weekday sessions begin at 6:30 PM, Weekend sessions begin at 8:00 AM

This course is designed to introduce new firefighters to interior fire ground operations including nozzles and streams, SCBA, rescue, ventilation, fire suppression, salvage and firefighter survival. This is the fourth and final module in the program.

Prerequisites - 18 years of age; Exterior Firefighter (Module III)

COST - In-County \$195; Out-of-County \$205

2012 SUPPRESSION TRAINING

ARSON DETECTION FOR THE FIRST RESPONDER - (16 hours)

April 21, 22 Weekend sessions begin at 8:00 AM

Upon successful completion, the student will be able to provide a clear definition of the role of initial responder organizations and to provide essential knowledge to enable them to recognize the potential of an intentionally set fire, preserve evidence and properly report the information to appropriate officials.

Prerequisites - 14 years of age

COST - In-County \$45; Out-of-County \$55

BUILDING CONSTRUCTION - WOOD & ORDINARY - (16 hours)

February 18, 19 Weekend sessions begin at 8:00 AM

The failure of a building or building components under fire conditions is a leading cause of firefighter death and injury. The ability to recognize and locate relevant information about a building before a fire and to “read” a building during a fire are essential survival skills. This course prepares the student to accomplish these skills in buildings of wood frame or ordinary construction.

Prerequisites - 14 years of age

COST - In-County \$45; Out-of-County \$55

BUILDING CONSTRUCTION—NON-COMBUSTIBLE & FIRE RESISTIVE - (16 hours)

March 17, 18 Weekend sessions begin at 8:00 AM

The failure of a building or building components under fire conditions is a leading cause of firefighter death and injury. The ability to recognize and locate relevant information about a building before a fire and to “read” a building during a fire are essential survival skills. This course gives the student the ability to accomplish these tasks when confronted with a building of fire-resistive or non-combustible construction. The unique problem of conducting emergency operations in buildings under construction are also addressed.

Prerequisites - 14 years of age

COST - In-County \$45; Out-of-County \$55

FOAM FIRE FIGHTING BASIC - (7 hours)

May 29, 31 Weekday sessions begin at 6:30 PM

This course, developed by National Foam, introduces the fire fighting first responder to basic information on the use of foam as a flammable liquid fire suppression agent. Topics covered include: foam terminology, concentration, solution, line proportioning equipment, application techniques and hands-on application of foam.

COST - In-County \$50; Out-of-County \$60

FORCIBLE ENTRY - (16 HOURS)

June 26, 28, 30 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This program will provide the firefighter with a better understanding of building construction as it relates to gaining entry into a building. The course will cover opening techniques and proper tool selection for safe and quick access into a structure. Hands on practical skills are included.

COST - In-County \$85; Out-of-County \$95

2012 SUPPRESSION TRAINING (continued)

STRUCTURAL FIRE RESCUE - (16 hours)

October 2, 4, 6 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This course will instruct the student in the methods of rescuing victims from buildings under fire conditions. Topics to be discussed and practiced are search procedures, victim handling techniques and methods of removing victims from above and below grade situations.

Prerequisites - 18 years of age; Interior Firefighter

COST - In-County \$80; Out-of-County \$90

TRUCK COMPANY OPERATIONS I - (16 hours)

May 15, 17, 19 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This course will introduce the firefighter to the basic duties of a truck company. Hand and power tool operation, search and rescue and ventilation are covered. Truck company support to the engine company is also covered.

Prerequisites - 18 years of age

COST - In-County \$95; Out-of-County \$105

TRUCK COMPANY OPERATIONS II - (16 hours)

June 19, 21, 23 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This course is designed for the firefighter to be able to refine and apply their knowledge of truck company operations. Advanced principles and hands-on evolutions in the area of vehicle placement, forcible entry, aerial operations, search and rescue, building construction, ventilation and predicting fire travel are covered.

Prerequisites - 18 years of age

COST - In-County \$95; Out-of-County \$105

2012 RESCUE TRAINING

BASIC RIGGING FOR ROPE RESCUE - (16 hours)

May 1, 3, 5 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

Participants in this course will be introduced to rope, rope hardware, patient packaging and basic haul systems, which can be used in various aspects of rescue. The intent of this course is to provide rope and basic rigging experience for anyone in rope rescue, but particularly those who do not want to, or are unable to rappel.

Prerequisites - 14 years of age

COST - In-County \$85; Out-of-County \$95

BASIC VEHICLE RESCUE AWARENESS - (16 hours)

March 31, April 1 Weekend sessions begin at 8:00 AM

August 14, 16, 18 Weekday sessions begin at 6:30 PM; Weekend sessions begin at 8:00 AM

The first module in the series, this class will provide rescue personnel with a basic knowledge of vehicle extrication procedures. Topics covered include vehicle anatomy, scene control, hazard control and procedures for assisting in the extrication process.

Prerequisites - 16 years of age

COST - In-County \$75; Out-of-County \$85

BASIC VEHICLE RESCUE OPERATIONS - (16 hours)

April 14, 15 Weekend sessions begin at 8:00 AM

September 4, 6, 8 Weekday sessions begin at 6:30 PM; Weekend sessions begin at 8:00 AM

The second module in the series, this course will teach the student in the use of hand tools as they relate to vehicle extrication. The student will learn how to safely and quickly access and package patients for removal from the vehicle.

Prerequisites - 16 years of age; Basic Vehicle Rescue Awareness

COST - In-County \$95; Out-of-County \$105

BASIC VEHICLE RESCUE TECHNICIAN - (16 hours)

April 28, 29 Weekend sessions begin at 8:00 AM

September 25, 27, 29 Weekday sessions begin at 6:30 PM; Weekend sessions begin at 8:00 AM

The third and final module in the series, this course will teach the student in the use of power tools, hydraulic rescue tools, disentanglement procedures, stabilization hazards and extrication procedures. Safety for both the rescuer and patient is emphasized.

Prerequisites - 18 years of age; Basic Vehicle Rescue Operations

COST - In-County \$95; Out-of-County \$105

CONFINED SPACE RESCUE AWARENESS - (4 hours)

June 6 Weekday session begins at 6:30 PM

This class will provide the participant with the information needed to identify confined spaces and assess the hazards associated with confined spaces in order to avoid serious injury or death. Information will be provided and alarm procedures discussed for handling confined space incidents as a first responder.

COST - In-County \$20; Out-of-County \$25

2012 RESCUE TRAINING (continued)

CONFINED SPACE RESCUE - (16 hours)

June 12, 14, 16 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This program trains students to conduct rescues from confined spaces. Topics covered include: scene management, size-up, risk benefit analysis, air monitoring and ventilation, entry techniques, patient packaging, removal and termination. Students will have the opportunity to apply techniques in actual confined spaces.

Prerequisites - 18 years of age; Basic Rigging for Rope Rescue

COST - In-County \$50; Out-of-County \$60

ELEVATOR RESCUE AWARENESS - (4 hours)

May 2 Weekday session begins at 6:30 PM

This course provides fire and rescue personnel with the ability to function safely and effectively during rescue incidents involving this mode of public transportation. Topics include: pre-incident planning, hazard assessment and size-up, rescue considerations, equipment identification and lockout / tagout procedures.

COST - In-County \$20; Out-of-County \$25

RIT AWARENESS - (4 hours)

February 29 Weekday session begins at 6:30 PM

This program will prepare fire department personnel for implementation of a stand-by rescue team at structure fires and certain other especially hazardous incidents. The course content relies heavily on the successful experiences of departments that have implemented and utilized the concept.

COST - In-County \$20; Out-of-County \$25

SPECIAL VEHICLE RESCUE TECHNICIAN - (16 hours)

October 23, 25, 27 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This course builds upon the knowledge and skills acquired in the Basic Vehicle Rescue series to prepare the students to deal with rescue situations involving larger vehicles such as buses and large trucks. A written examination is administered at the conclusion of this course for certification as a Special Vehicle Rescue Technician.

Prerequisites - Basic Vehicle Rescue Technician

COST - In-County \$105; Out-of-County \$125

STRUCTURAL COLLAPSE OPERATIONS I - (4 hours)

September 5 Weekday session begins at 6:30 PM

This course is designed to familiarize students with operations at the scene of a structure collapse so they may be able to function at the initial stages of a structure collapse operations, identify and mitigate hazards, recognize the need for assistance and perform as an integral part of the overall operation once technical rescue teams are on site.

Prerequisites - 14 years of age

COST - In-County \$20; Out-of-County \$25

2012 RESCUE TRAINING (continued)

TRENCH RESCUE AWARENESS - (4 hours)

February 15 Weekday session begins at 6:30 PM

This course will give the responder the knowledge of how to respond to a trench collapse emergency. The course will point out the hazards associated with trench collapse and actions that the responder can take prior to the arrival of the rescue team. Topics include case studies, collapse types, hazard control and identification, shoring overview and initial response actions.

Prerequisites - 14 years of age

COST - In-County \$20; Out-of-County \$25

WATER RESCUE AWARENESS - (4 hours)

March 14 Weekday session begins at 6:30 PM

This program discusses the characteristics of water-related emergencies and the health and safety risks to First Responders. The program addresses the common hazards associated with water rescue emergencies, as well as, the First Responders initial role, on-scene responsibilities and responder limitations.

Prerequisites - 14 years of age

COST - In-County \$20; Out-of-County \$30

2012 HAZARDOUS MATERIALS TRAINING

HAZARDOUS MATERIALS AWARENESS - (4 hours)

January 11 Weekday session begins at 6:30 PM

This course is designed for individuals likely to witness or discover a hazardous materials release and who have not been trained to take any action beyond notifying proper authorities.

Prerequisites - 14 years of age

COST - In-County \$20; Out-of-County \$25

HAZARDOUS MATERIALS OPERATIONS - (24 hours)

March 10, 11, 24 Weekend sessions begin at 8:00 AM

September 11, 13, 18, 20, 22 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

The goal of this program is to provide the First Responder with the training needed to comply with NFPA 472 Chapter 5 Competencies for the First Responder at the Operational Level and 29 CFR 1910.120 OSHA's Hazardous Waste Operations and Emergency Response (HAZWOPER) Fire Responder Operations Level. This program is designed to give the first responder the necessary skills to handle hazardous materials emergencies. After successfully completing this course you would be eligible to take the national certification testing for certification at the Hazardous Materials Operations Level.

Prerequisites - 16 years of age

COST - In-County \$70; Out-of-County \$80

HAZARDOUS MATERIALS OPERATIONS REFRESHER - (6 hours)

April 10, 12 Weekday sessions begin at 6:30 PM

August 21, 23 Weekday sessions begin at 6:30 PM

This course will provide the student with a review of the skills necessary to operate at the Operations Level at a hazardous materials incident. This course meets the requirements for annual review in Federal Regulation 29 CFR 1910.120.

COST - In-County \$25; Out-of-County \$30

2012 APPARATUS TRAINING

DYNAMICS OF EMERGENCY VEHICLE RESPONSE - (4 hours)

March 7 Weekday session begins at 6:30 PM

This course is designed as a supplement to the Emergency Vehicle Operators Course (EVOC). This course reviews some basic philosophies of safe vehicle response and operation and introduces the concept of space and speed management in the operation of any vehicle.

Prerequisites - Emergency Vehicle Operators Course (EVOC)

COST - In-County \$20; Out-of-County \$30

EMERGENCY VEHICLE OPERATORS COURSE (EVOC) - (16 hours)

April 21, 22 Weekend session begins at 8:00 AM

September 29, 30 Weekend session begins at 8:00 AM

This course provides instruction for emergency personnel who will be involved in the operation of emergency equipment. Course content includes defensive driving, emergency response, vehicle maintenance and the driver training obstacle course.

Prerequisites - 18 years of age; Valid Drivers License

COST - In-County \$50; Out-of-County \$60

PUMP OPERATIONS I - (16 hours)

May 1, 3, 5 Weekday session begins at 6:30 PM; Weekend session begins at 8:00 AM

This course provides the firefighter or driver/operator with an introduction to basic pump construction and theory as well as operating techniques. Course emphasis is placed on getting water to the pump, getting water from the pump to the hose stream and prevention of common mistakes that occur during pump operations.

Prerequisites - 18 years of age

COST - In-County \$50; Out-of-County \$60

PUMP OPERATIONS II - (16 hours)

June 12, 14, 16 Weekday session begins at 6:30 PM; Weekend session begins at 8:00 AM

This course is designed to instruct the student in advanced techniques of operating fire pumps. Topics include friction loss, relay pumping, master streams and elevated master streams.

Prerequisites - Pump Operations I

COST - In-County \$50; Out-of-County \$60

2012 COMMAND / MANAGEMENT TRAINING

INCIDENT SAFETY OFFICER - (16 hours)

January 21, 22 Weekend sessions begin at 8:00 AM

October 23, 25, 27 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This course focuses on the duties of the person who finds him/herself in the role of the responding safety officer at the scene of an incident. It is an incident specific, scene oriented course designed to teach what a safety officer on the scene needs to know and be able to do, using scenarios to convey instructional points. Students should be experienced company officers, familiar with safety issues, the Incident Command System, hazardous materials management and applicable NFPA / federal regulations.

COST - In-County \$45; Out-of-County \$55

INTRODUCTION TO FIRE OFFICERSHIP - (16 hours)

April 14, 15 Weekend sessions begin at 8:00 AM

This course will give the student a basic overview of fire ground officer responsibilities, personnel issues, fire ground operations and the development of a sound and effective administrative and fire ground organizational structure.

COST - In-County \$45; Out-of-County \$55

MANAGING COMPANY TACTICAL OPERATIONS - PREPARATION - (16 hours)

January 16, 18, 23, 25 Weekday sessions begin at 6:30 PM

This course, the first in the series, is intended to provide new or future officers with the skills necessary to participate in the successful and safe management of company level tactical operations. This course is a prerequisite for the remainder of the MCTO series.

Prerequisites - ICS or NIMS

COST - In-County \$45; Out-of-County \$55

MANAGING COMPANY TACTICAL OPERATIONS - DECISION MAKING - (16 hours)

March 19, 21, 26, 28 Weekday sessions begin at 6:30 PM

This course, the second in the series, will help the student develop the necessary skills to manage company level tactical operations. Topics include incident command at structural fires, command sequences, size-up, developing an action plan and how to implement the action plan.

Prerequisites - Managing Company Tactical Operations - Preparation

COST - In-County \$45; Out-of-County \$55

MANAGING COMPANY TACTICAL OPERATIONS - TACTICS - (16 hours)

December 3, 5, 10, 12 Weekday sessions begin at 6:30 PM

This course, the third in the series, will help the student develop the necessary skills to manage company level tactical operations. Topics include tactical action modeling, ventilation and rescue considerations, confinement and extinguishment, water supply and exposure protection, salvage, overhaul and support activities.

Prerequisites - Managing Company Level Tactical Operations - Decision Making

COST - In-County \$45; Out-of-County \$55

2012 FIRE POLICE TRAINING

BASIC FIRE POLICE - (16 hours)

January 10, 12, 17, 19 All sessions begin at 6:30 PM

This course sets forth the need for fire police, as well as their legal police power, personal and professional qualifications, appoint and control, general and special duties and limitations.

Prerequisites - None

COST - In-County \$45; Out-of-County \$55

ADVANCED FIRE POLICE - (16 hours)

October 2, 4, 9, 11 All sessions begin at 6:30 PM

This course will touch upon the training and the training officer's qualifications, policy and procedures, legal liabilities, court appearance, leadership, communications and public relations, defensive driving, traffic control, security, self-protection and uniforms.

Prerequisites - Basic Fire Police

COST - In-County \$45; Out-of-County \$55

EMERGENCY RESPONSE FOR FIRE POLICE - (16 hours)

January 24, 26, 28 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This course covers in-depth: response vehicles, response routes, equipment, clothing, preparation, personal ability, defensive driving, the approach to the scene, man-made disasters (Haz-Mat, etc), natural disasters (floods, etc), lost person search, disease exposure and accounting for personnel.

Prerequisites - Basic Fire Police

COST: In-County \$45; Out-of-County \$55

FIRE POLICE IN NON-EMERGENCY OPERATIONS - (16 hours)

February 7, 9, 11 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This course will detail the work of fire police on duty for funerals, fairs, parades, sports events, school events, municipal events, holidays and other functions.

Prerequisites - Basic Fire Police

COST - In-County \$45; Out-of-County \$55

LEGAL CONCEPTS FOR FIRE POLICE - (16 hours)

October 13, 16, 18 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This course consists of an in-depth study of the laws with which fire police, fire departments and their municipalities are jointly involved. This includes powers, negligence, liability, detention, lawsuits, training, insurance, courtroom procedures, vehicle codes and regulations and the crime code.

Prerequisites - Basic Fire Police

COST - In-County \$45; Out-of-County \$55

PUBLIC RELATIONS FOR FIRE POLICE - (16 hours)

October 30, November 1, 3 Weekday sessions begin at 6:30 PM; Weekend session begins at 8:00 AM

This course will help fire police to communicate their ideas effectively, how to listen and understand the words and messages directed to them and if response is required, how to use tools of communication and communications work in public relations.

Prerequisites - Basic Fire Police

COST - In-County \$45; Out-of-County \$55

EMERGENCY MEDICAL TRAINING

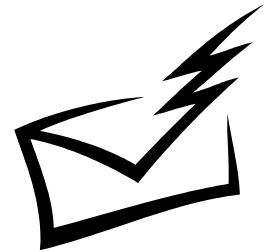

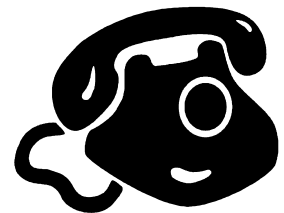
